The meeting opened at 10:00 a.m. with Chair, Sissy Crowther, welcoming everyone especially VOF's newest board members, Elizabeth Copeland and Tack Richardson appointed by Governor Younkin.

# **Approval of The Order of Business**

Motion to made by Eleanor Brown to move the Lambert Resolution to the closed session and to move the Closed Session before the Strategic Plan Discussion; motion seconded by Viola Baskerville and passed unanimously.

# **Approval of Minutes**

Motion made by Eleanor to correct the June 30, 2022, Board of Trustees minutes - changing the amount of Preservation Trust Fund (PTF) dollars mentioned in the director's report from \$1,000,000 to \$4,000,000 and to approve the minutes of the Finance Audit and Compliance Committee Meeting as presented; motion seconded by Viola and passed unanimously.

# **Director's Report**

Brett reported on/ relayed information on the following items:

- Governor Younkin is expected to attend the opening of Blackwater Park, a recipient of a VOF PTF grant in City of Franklin.
- VOF has its first easement in the city of Colonial Heights. The project is part of the Lower Appomattox River Trail project and was funded in part by a VOF PTF grant to the Capital Region Land Conservancy to acquire the historic Harvell Dam parcel.
- 2022 is the 25<sup>th</sup> anniversary of PTF. Brett encouraged everyone to view the story board map on the VOF website containing highlights of what PTF, through VOF's leadership, has accomplished over the past 25
- The trend line for land conservation funding via the Virginia Land Conservation Fund (of which PTF receives 25%) has been going up thanks to our friends and colleagues.

- Martha Little and Brett will be conducting another site visit with staff from Department of Conservation and Recreation at Hayfields, in Highland County on the 21<sup>st</sup> of October.
- On the 8<sup>th</sup> of October a Descendants Day was celebrated at Bull Run Mountain Natural Area Preserve. Surrounded by the preserve is the Robinson/Corum Family Cemetery. Over 30 descendants, many of whom had not been to the cemetery since childhood attended. With many generations of Robinsons and Corums present to visit the family resting place, the attendees ages spanned from 80+ to 8 years of age.
- VOF sent several staff members to the Land Trust Alliance (LTA) annual national convention in New Orleans.

Brett asked Anna to review a 1<sup>st</sup> quarter budget update. This presentation is on file with the permanent record of this meeting.

Brett introduced a video produced by LTA and shown at the annual convention celebrating the award of the 2022 Kingsbury Browne Conservation Leadership Award to Ebonie Alexander of Virginia for her tireless work on heirs' property. This video is on file with the permanent record of this meeting. Viola spoke to the challenges of heir's property.

WHEREAS, on July 9, 2008, the Board of Trustees approved a resolution to strongly encourage the use of the approved model deed for the Enforcement, Notice, and Extinguishment provisions of the then current easement model deed; and

WHEREAS, on October 21, 2009, the Board of Trustees approved a resolution requiring that easements presented to the board for its consideration include without deviation the following provisions of the then current model deed – Right of Inspection, Enforcement, Documentation, Duration, and Notice; and

WHEREAS, to facilitate timely review of prospective easements and streamline the administration of easements two additional provisions of the model deed must be included in all easements presented to the board for its consideration; and

WHEREAS, the Virginia Outdoors Foundation Board of Trustees concur that the following provisions of the model deed as now posted on the Virginia Outdoors Foundation website and as amended from time to time and later posted on the Virginia Outdoors Foundation website, must be included in all easements presented to the Board of Trustees for its consideration as written:

Section III Enforcement including Paragraph 1. Right of Inspection and Paragraph 2. Enforcement

Section IV Documentation

Section V Paragraph 1 Duration

Section V Paragraph 6 Construction

Section V Paragraph 8 Notice to Grantee and Grantor

Section V Paragraph 17 Cost Recovery Charges, now therefore, be it

RESOLVED that the provisions described above must deal exclusively with the subject matters treated therein, and no provisions elsewhere in proposed deeds of easement may conflict with the language of such provisions, and be it further

RESOLVED that on this 11th day of October 2022 this resolution repeals, supersedes, and replaces all provisions of the Trustees' Resolution to require the use of approved model deed for Right of Inspection, Enforcement, Documentation, Duration, and Notice.

WHEREAS, the Gerard B. Lambert Foundation donated a parcel of land to VOF in Scott Magisterial District, Fauquier County north of Rectortown containing 57.02 acres improved with a house (PIN#6062-68-6792) by deed recorded August 13, 2021; and

WHEREAS, the property was accepted by VOF as an acquisition of real property for open space preservation pursuant to the purposes of § 10.1-1800; and

WHEREAS, the property was gifted to VOF by deed recorded August 13, 2021 subject to a life estate, an open space easement held by VOF dated December 4, 2003 and recorded in Deed Book 1074 at Page 775 in the Clerk's Office of the Circuit Court of Fauquier County (the "Existing Open-Space Easement"), and other easements, right of ways, or restrictions of record; and

WHEREAS, the property is well suited for protection of its conservation values by open space easement and the Existing Open Space Easement does not adequately protect the property, by current standards, including but not limited to the fact that the Existing Open Space Easement offers insufficient riparian protections to Goose Creek, and no aggregate cap on impervious coverage for buildings; and

WHEREAS, by Resolution adopted by the Board of Trustees at the June 30, 2022, meeting, the Executive Director was authorized to list the property with a realtor subject to perpetual deed restrictions, an amendment to the Existing Open Space Easement and/or an additional open space easement designed to protect the specific conservation values and for the purpose of open-space preservation. The sale parcel also being subject to the life estate, and any other matters of record. The proceeds from the sale to be dedicated to support and benefit work at the VOF Bull Run Mountains Natural Area Preserve including the preservation of the open space of the VOF Bull Run Mountains Natural Area Preserve; and now, therefore, be it

RESOLVED by the Virginia Outdoors Foundation Board of Trustees this 11<sup>th</sup> day of October 2022, that VOF hereby authorizes the Executive Director, in consult with the Chair, to accept an offer for the 57.02 acres on terms and conditions the Executive Director and Chair deem reasonable.
