This application requests funding for the purchase of land and right-of-way for the construction of Phase III of the Town's Riverwalk project. Riverwalk is a shared-use path along the edge of the North River that will eventually span over two miles and create an east-west pedestrian and bicycle connector across the Town. Two phases have been funded already, and with this grant we'd begin work immediately on Phase III.

Project Description

1. Describe the property, including the existing conditions (size and composition of property, natural resource values,
recreational, scenic, and cultural resources, and/or significa-	ant landscape features).

The project site for the Riverwalk Phase III path is approximately 1,000 feet in length. It will require the acquisition of four easements and the purchase of one parcel of land. Four of the easements are located on East Riverside Drive, spanning about 375 feet. This will be for the installation of a sidewalk along East Riverside Drive, as no sidewalk currently exists on the south side of the street. The Town also needs to acquire a parcel of real estate to create another 625 feet of shared-use path. This parcel is 3.112 acres in size and has an assessed value of \$9,300. The lot is undeveloped, part open space and part wooded land, which also includes a small island on the North River. Purchasing the lot would protect the land along the river in its natural, wooded state. We would preserve the lot as it is, perhaps creating a scenic overlook on and around the island in a future grant. The lot is a beautiful landscape feature that would be an attractive addition to the Riverwalk path. Its acquisition would protect and create a recreational and scenic feature for the Town.

2. Describe the planned method of land protection for this project (i.e., how the PTF requirement for a conveyance of real estate interest to VOF or a locality will be met)

The Town will purchase a 3.112 acre parcel of land that will be used for the Riverwalk path and additional land which will be preserved as open, public park space. The land will be conveyed to the Town by deed, with the purchase price paid through this grant. The Town will also purchase four easements between this 3.112 acre parcel and Edgebriar Park, which is already owned by the Town. Those easements will be appraised, with the purchase price paid through the proceeds of this grant.

3. List the proposed goals and objectives of the project.

The goal of this public access grant is to allow us to purchase and preserve green space while allowing us to expand our Riverwalk walking and bicycle path further east across Town. There are several objectives to the Riverwalk project. One is to create a safe, accessible walking and bicycle path between Wildwood Park on the west side of Bridgewater and Sandy Bottom Park on the east side of Bridgewater. This distance spans approximately two miles. With Riverwalk we hope more people will use it to travel across Town, reducing the need to drive a vehicle. A further benefit is to encourage people to walk or bike, which encourages better health of our residents. Another benefit of the Riverwalk path is to serve populations that may not have a vehicle and are reliant either on public transportation or walking to reach their destination.

4. Is this project part of a larger movement (e.g. Have other projects of a similar nature happened near this one? Is this one of many that are ongoing in this area?)

Yes, this would be Phase III of the Town's Riverwalk project. Phase I installed a 1,000 foot path connecting four of our parks along the North River. Phase II will continue the project westward through another park and connecting another neighborhood. Phase III would extend the path another 1,000 feet to the east. The master plan will create a Riverwalk multi-use path connecting Wildwood park on the west side of Bridgewater with Sandy Bottom Park on the east side, with a total length of about two miles. A growing number of residents and visitors enjoy walking and biking around Bridgewater for recreation. Others rely on sidewalks and shared-use paths to get to work, pickup groceries, or visit Bridgewater businesses. Phase I has been heavily used for recreation and getting around Town, so we anticipate future phases being used even more as Riverwalk connects more neighborhoods.

5. How will this area be managed in the future?

The Town will maintain this portion of Riverwalk, along with all other current and future portions of Riverwalk. The Town Public Works Department will keep the path clear, handle mowing and landscaping of the area around Phase III.

Community Description

6. Describe the community being served by this project. Describe the importance of this project to the community and address how this project will better serve the community.

Riverwalk (this phase and all current and future phases) serve three different subsets of the Bridgewater community. One, it serves residents looking for recreational activities. Phase I of Riverwalk connects four different town parks, including the Town's recreational park. Phase III extends the use of recreational use, connecting two additional neighborhoods to create a longer walking path.

Second, Riverwalk helps individuals who have limited access to transportation. By creating a path to walk across Town, Riverwalk helps individuals gain access to Main Street, which already has sidewalks throughout the rest of its span through Bridgewater. Phase III further builds on this public access network. The addition of Riverwalk Phase III would better serve the residents in this neighborhood. The average home prices of the properties in this corridor (\$106,380) rank in the bottom quarter of property values in the Town. While recent income levels were not available at the time of this application, household income levels in this neighborhood are likely in the bottom third of Bridgewater residents based on the average home prices noted above along with the higher percentage of apartments and rental properties in this neighborhood. We have spoken to some residents who live here who do not have vehicles, so they rely upon walking or public transportation to get around. Installing the sidewalks and shared-use paths in this neighborhood will improve connectivity and likely boost property values in this neighborhood.

Finally, Riverwalk is tourist attraction, as people visit the Town to walk the path. As the path gets longer, it further connects portions of Town and lends itself better to visits by tourists.

7. Describe how the community has been involved in the development of this proposal and/or will be involved in the implementation of this project. Describe how community support is shown for this project.

The Bridgewater community has been active in the development of the Riverwalk project. Public information meetings were held for Phase I (2016) and Phase II (2018), and another meeting will be held for Phase III in September 2021. Public support for Riverwalk has been very strong, as members of the community and visitors have actively used Phase I since its completion in January 2021. Also, there have been dozens of residents who have called or emailed the Town approving of Phase I and are in support of adding additional phases to the Riverwalk project.

Phase I was dedicated in the memory of the late Roscoe Burgess, the first African-American resident to serve on the Bridgewater Town Council. Its dedication in May 2021 was well attended and further publicized the park, and the popularity of Riverwalk has continued to grow. Attached to this application are letters of support for Riverwalk, which reflects the growing support for additional walking and bicycle paths in Bridgewater.

8. How does this project address a specific need in the community or provide a unique service to the community?

It addresses several specific needs in the Bridgewater community. One, there is a demand for recreational access to parks and neighborhoods. Riverwalk addresses this, as the long-term plan will be to connect the most western and eastern parts of Bridgewater through the roughly two mile Riverwalk path. There is a strong demand for walking and bike paths, so Riverwalk Phase III builds upon the existing network and connects additional neighborhoods to the path. Second, there is a need for pedestrian and bicycle access as a means of transportation for residents to work and accessing businesses. By creating a safe, ADA accessible path, we are giving residents better access to Main Street, which is the primary location of most of the Town's businesses along with three bus stops of our regional bus network. Some residents in the Riverwalk Phase III neighborhood do not own vehicles, so improving pedestrian access to Main Street is of great importance and value to those residents. Finally, the Town receives many tourists who visit the Town, and Riverwalk is an attraction that is visited by many outside of the Town. Lengthening Riverwalk will make it even more so a tourist destination as visitors walk the path and enjoy the natural beauty of the North River.

If this grant is received, we will begin work immediately, with the Town funding the costs of installing the path along Phase III. Receiving this grant will allow us to move forward with additional phases of Riverwalk, which we will likely partner with VDOT for additional funding. We have already received a grant from VDOT which was used for constructing Riverwalk, Phase I, and we just received approval from VDOT in Fall 2020 for funding Phase II of Riverwalk. We are in the process of applying for additional funds for Phase III of Riverwalk through a Transportation Alternatives grant that is due in October 2021. We have used volunteers in the past to help with some landscaping at some of our parks. For example, we have worked with Bridgewater College student groups that have come to help us with weeding and planting flowers. We will most likely continue

to work with groups like Bridgewater College at Riverwalk.

10. Provide any other information about this project that makes it unique/special. If the area has special significance to the community, please describe it here.

The North River is one of the most recognizable natural landmarks around Bridgewater. The first bridge over the North River was built in 1820, hence our town's name "Bridgewater." Having a shared-use path along the river encourages people to enjoy the natural beauty of the North River and our parks. Riverwalk also functions to allow people to safely walk from one side of town to the other without having to walk across the heavily-traveled Main Street. As we build onto Riverwalk, we believe it will become an attraction in of itself and encourage visitors to check out all of our 13 parks, movie theater, ice skating rink, restaurants and businesses that call Bridgewater home.

Schedule

11. Describe the timeline/plan of work for this project. Include who is expected to do the work and when. Work that has already been completed toward the project should be mentioned here.

If the PTF grant is received, the Town will purchase the real estate and easements needed for Riverwalk, Phase III immediately. We will work with our Town attorney to handle the acquisition of real estate and easements along the Riverwalk, Phase III path. Once the land is purchased and easements acquired, the Town will begin construction of Phase III. The Town would likely perform some of the work ourselves, although we would probably hire a subcontractor for installing the pavers used for the path. We would anticipate completing Phase III within 9 months of receiving this grant. No work has been completed at this point on Phase III of Riverwalk.

The budget for the project includes the purchase of real estate and easements, attorney's fees, and the installation of the Phase III path. The path will consist of a concrete sidewalk or a permeable paver path. The Town will use this grant to fund the purchase of real estate and easements, which will total about \$55,000. The remaining costs of the project will be for the installation of the sidewalk and paths. The Town is applying for a VDOT Transportation Alternatives grant for \$300,000 for engineering costs and construction of the path. Volunteers will be used to help with landscaping along the Riverwalk path.

17. Explain if the grant funding is a key component to getting the project started or completed.

This PTF grant would be a key component to getting Phase III of Riverwalk started. Receiving this grant would allow us to immediately purchase the land and easements necessary to begin the project. With those funds secured and easements in hand, we will be able to begin building the Phase III path immediately. If this PTF grant is not funded, we will not begin Phase III until further funding is secured.

Starting Phase III with this grant will allow us to begin work now on additional phases of Riverwalk.

18. Address how reduced funding would impact the scope of the project. Please address viability and scope at 75% and 50% of the requested funding.

Riverwalk, Phase III would still be viable with 50% or 75% grant funding. We would need to budget for this cost difference, but could adjust our FY2022 budget for those additional costs. While a 100% grant for the funds requested in this application would be optimal, we would be very appreciative of any funding that could be used to begin this project. Phase III of Riverwalk will not begin until we receive some type of grant funding, either through this grant or some other grant application.

The intersections of Old River Road and North River Road with North Main Street present problems for motorists. Tractor trailers entering onto North Main Street must block traffic both directions in order to make turning movements north and south. Traffic attempting to enter Main Street during peak use hours is often backed up for significant amounts of time. The location of several industrial complexes in this area suggests traffic conflicts can be expected to continue or increase in severity.

Many roadways within the Town were constructed to rural-road standards prior to annexation by Bridgewater. The older roadways lack curb and gutter and sidewalks, and some are built to narrower widths than urban road standards. Most Town roadways have good pavement conditions. A plan establishing bike lanes throughout town has been approved by the Town Council. The Town is currently responsible for

maintaining approximately 35.91 lane miles of secondary and 12.60 lane miles of primary highways.

Amtrak service is available in Staunton, approximately twenty-five minutes south of town. Railway freight services are available in Harrisonburg. Commercial passenger air services are available at the Shenandoah Valley Regional Airport in Weyers Cave, approximately fifteen minutes southeast of Bridgewater.

Goal: Promote a balanced, safe, and efficient transportation system serving the Town.

Objective: Maintain and upgrade the roadway system as needed to accommodate both vehicular, bicycle, and pedestrian traffic.

- Identify needed improvements to existing roadway widths and construction of sidewalks. Priorities
 for improvements should be established and coordinated with long-range highway improvement
 plans and Town capital improvement projects.
- Redesign selected intersections to promote safe and efficient traffic flow, particularly in the vicinity of North River Road and Mount Crawford Avenue.

Objective: Promote safer and more efficient truck access to industrial sites.

- Town officials, local industry representatives, VDOT officials, and local residents should work together to obtain the construction of a truck road between North Main Street (Route 42) and Dinkel Avenue (Route 257).
- VDOT officials should assist in the study of key North Main Street intersections to determine the need for roadway widening, signalization, or other improvements.



New sidewalks can be installed using grant money or development requirements, or by "in-house" projects completed by our crew, like this one on Mountain View Drive.

- The Town should work with Perdue and Marshalls to close Quality Street and reroute truck traffic to Old River Road. A traffic signal and appropriate turning lanes should be installed at this intersection to allow easy truck access to and from the industrial sites.
- VDOT officials should assist in the study of key North Main Street intersections to determine the need for roadway widening, signalization, or other improvements.

Objective: Ensure that new development includes roadways designed to serve anticipated traffic volumes and pedestrian needs.

- Enforce adopted design standards for roadway widths, entrances, and construction specifications.
- Develop and implement strategies ensuring that new developments must integrate with the townwide transportation system. For example, new developments should connect to one another and not simply shunt all traffic to Main Street or Dinkel Avenue

Objective: Encourage alternatives to vehicular use.

- Install bicycle lanes and bicycle or walking trails in targeted areas.
- Install a multi-use path along North River from Sandy Bottom to Wildwood Park.
- Install safe, modern crosswalks where needed on busy streets. Take other such measures as necessary to make Main Street more walkable.
- Work with VDOT and Harrisonburg to establish bike trails between Bridgewater and Harrisonburg.







