




ABOUT US

The Virginia Outdoors Foundation (VOF) is Virginia's leader in land conservation, protecting nearly 900,000 acres across the Commonwealth. Created by the Virginia General Assembly in 1966, today the foundation receives both public and private support for its work. VOF works with local, state, federal, and private partners to protect a wide variety of open spaces, from farms and forests to parks and historic landscapes.

E X E C U T I V E S U M M A R Y

During fiscal year 2023, the Virginia Outdoors Foundation conserved more than 11,000 acres of farmland, forestland, and other open space across 30 localities. VOF also provided more than \$3.27 million in grants to local governments, schools, nonprofit, and other organizations to protect open space and make the outdoors more accessible to Virginians throughout the Commonwealth. Whether funding community gardens, trails, playgrounds, and other amenities in neighborhoods, or protecting family farms for future generations, we are proudly helping to connect thousands of Virginians to the outdoors and to each other.

OPEN-SPACE EASEMENTS

Landowners who wish to protect their land from future intensive development may grant open-space easements to VOF in perpetuity. VOF is a national leader in land conservation, with more than 4,000 properties protected across the Commonwealth, many of them working farms and forests.

LAND ACQUISITION


VOF serves an important role for the Commonwealth by accepting gifts of land for public benefit, as well as by assisting other state agencies in acquiring properties to be used as state parks, wildlife management areas, and preserves. VOF itself owns and manages approximately 4,000 acres of openspace reserves.

CONSERVATION FUNDING

Through various programs, VOF provides grants to landowners, organizations, and government partners who protect open space for recreation, wildlife habitat, historic preservation, farming, forestry, scenic beauty, and water quality.

O P E N - S P A C E E A S E M E N T S

Open-space easements are voluntary agreements between landowners and public bodies such as the Virginia Outdoors Foundation that permanently limit future development on land to protect conservation values such as water quality, scenic beauty, wildlife habitat and more for public benefit.

Most VOF easements are on working farms and forests, which contribute food and fiber to our communities and collectively represent Virginia's largest industry.

In Fiscal Year 2023, VOF protected approximately 11,100 acres of open space on new and amended easements in 30 localities.



Orange County

A 348-acre farm located along a scenic byway and in a historic district. More than half of the property contains Prime Soils and Farmland of Statewide Importance as designated by the USDA.



Rappahannock County

A 101-acre forested property that contains a tributary of the Hazel River, fronts a scenic byway, and lies within the historic boundaries of Belle Ridge Farm, eligible for listing on the Virginia Landmarks Register.



Fauquier County

A 330-acre easement first recorded in 1977 was amended to remove all remaining division rights, limit impervious surfaces, and add a 50-foot riparian buffer along more than a mile of the Little River and its tributaries.



Highland County

A 680-acre farm called Dividing Waters that contains the headwaters of the Jackson River and the South Fork of the Potomac River. The working cattle farm is enrolled in cost-share programs to fence livestock out of the waterways.



Augusta County

A 150-acre cattle farm with extensive protections for waterways and soils. The farm is used as an outdoor classroom for students from James Madison University and for seminars by employees of the Department of Conservation and Recreation



Bath County

Three neighboring forested properties totaling 778 acres that are near the Highland Wildlife Management Area and contain sinkholes, caves, and tributaries of the Bullpasture River.



Hanover County

A 215-acre designated Virginia Century Farm that includes the historic home "Airwell," which has been in the same family for more than 300 years. The farm is visible from a public road that is part of a regional cyling trail.



Sussex County

A 555-acre farm with more than two miles of frontage along the Nottoway River. Areas of the property provide habitat for a variety of wildlife and plant species in a natural, undeveloped state.



Westmoreland County

A 442-acre property bordering Westmoreland State Park. The easement was acquired with a grant from the U.S. Navy and helps to prevent development encroachment of the Naval Support Facility in nearby Dahlgren.



Bedford County

A 381-acre farm that has been in the same family for six generations. Approximately 200 acres of the farm soils are designated as "Prime Farmland" or "Soils of Statewide Importance" by the USDA.



Amherst County

A 274-acre cattle farm that lies within the Pedlars Mills Rural Historic District and fronts the Pedlar River, which is part of the state-designated Pedlar River-Pedlar Mills-Browns Creek Stream Conservation Unit.



Halifax County

A 744-acre farm that fronts the Dan River for about 1.5 miles and contains the 18th-century house known as Riverside, which is listed on the National Register of Historic Places and the Virginia Landmarks Register.



Russell County

A 71-acre forested property that lies on the north side of the Clinch Mountain Range, is located near Channels State Forest, and flanks the west side of Route 80, which is designated as the "Trans-America Bike Trail."



Washington County


A 2.78-acre easement on White's Mill, one of the few remaining operational watermills in Virginia and an asset of significant historical value to the communities of southwest Virginia. The property is open to the public.



Montgomery County

One of three parcels that comprise Brush Mountain Park, a 635-acre recreational property managed by the Town of Blacksburg. The park contains 18 miles of multi-use trails and connects to the vast and heavily utilized Poverty Creek Trail system.

CONSERVATION FUNDING

PRESERVATION TRUST FUND

Established in 1997, the Open-Space Lands Preservation Trust Fund provides grants for acquisitions, easements, rights of way, and other methods of protecting open space for farming, forestry, recreation, wildlife, water quality, and more.

TERRA / FOREST CORE


Established by VOF to administer funds resulting from legal and regulatory actions involving Virginia's natural resources.

GET OUTDOORS

Established in 2020, the Get Outdoors Fund provides flexible, adaptable grants for projects that increase access to safe open space for all Virginians.

Keep Prince William Beautiful, Prince William County ←

\$10,000 to renovate a trail and outdoor classroom used by Dale City Elementary School along Neabsco Creek.





INMED Partnerships for Children, Loudoun County A

\$25,000 to teach aquaponics, gardening, and environmental education to lowincome residents of the Leesburg Mobile Home Park.

Friends of the Rappahannock, Stafford County ▼

\$15,000 to provide bilingual river safety programs and outreach materials to schools, recreation programs, and first responders around the Rappahannock River.



Town of Clifton Forge, Alleghany County ▼

\$10,000 to convert an existing playground into an all-abilities playground with safe surfacing and specialized play equipment, to allow children of all abilities to play together.





Downtown Riverfront, City of Buena Vista 🔺

\$50,000 for a new path and boat ramp that will link the downtown's brewery, restaurants, and shops directly with outdoor recreation on the Maury River.

North Fork Access Shenandoah County 🕶

\$300,000 to purchase 14 acres along the North Fork of the Shenandoah River that will improve access to Seven Bends State Park, including new boat ramps and parking.



Larchmont Trailhead, City of Norfolk ▼

\$404,625 to establish the Larchmont Trailhead for the Elizabeth River Trail. The trailhead will include accessibility improvements, new signage, and a kayak launch.





OpenSpace Education, City of Richmond ▲

\$25,000 to provide tuition-free access to art education, safe outdoor time, and alternative modes of learning in partnership with Richmond Public Schools.

Franklin Parks Foundation, City of Franklin ▼

\$200,000 to acquire two parcels for the creation of Blackwater Park, a new city park on the State Scenic Blackwater River.



Town of Kenbridge, Lunenburg County ▼

\$79,750 to create a paved connector trail from the existing 0.5-mile loop trail around Kenbridge Town Park to the sidewalk at the front of the property.





Wildrock, City of Charlottesville 🔺

\$2,500 for Wildrock's Outdoor Explorers Program to bring children from a Title 1 elementary school to a local park where staff facilitate nature play.

Perrymont Park, City of Lynchburg ▼

\$169,000 to develop a park in an underserved neighborhood with a walking loop, restored wetlands, ball fields, an outdoor classroom, and nature paths.



Star City Cycling, City of Roanoke ▼

\$15,000 to develop a transportation program that takes disadvantaged kids to supervised mountain biking and hiking activities offered by Star City Cycling and Humble Hustle.





Town of Dungannon, Scott County ▲

\$150,000 for the creation of a community-owned river research and learning center on the Clinch River that will partner with local high schools, colleges and civic groups.

Ivanhoe Civic League, Carroll County ▼

\$25,000 to improve facilities and camping sites and add a new fitness trail and playground area at Jubilee Park and Horse Show Grounds.

O P E N - S P A C E R E S E R V E S

The Virginia Outdoors Foundation manages five open-space reserves across the Commonwealth: Bull Run Mountains in Prince William & Fauquier counties, House Mountain in Rockbridge County, Rockfish in Nelson County, Kohls Island in Northumberland County, and Blue Ball Mountain in Clarke County. Together, these reserves protect about 4,000 acres of open space for future generations, much of which is accessible for hiking, wildlife watching, and scientific study. RESERVE HIGHLIGHTS



News & Partnerships

- VOF received a \$70,000 grant to further research the history of human settlement in the Bull Run Mountains Natural Area Preserve in Northern Virginia, as well as a \$500,000 grant from the Virginia Land Conservation Foundation to acquire a threatened parcel adjacent to the Jackson Hollow section of the preserve.
- VOF hosted numerous guided hikes and other activities for local schools, Girl Scouts, Master Naturalists, and more at Bull Run Mountains to connect users to the area's cultural history and rich ecology, from wildflowers and fungi to insects and amphibians.
- VOF hosted groups from the Virginia Military Institute and the Environment Virginia Symposium for hiking events at our House Mountain Reserve in Rockbridge County.
- VOF transferred our Hayfields Reserve property in Highland County to the Virginia Department of Conservation and Recreation for future use as a state park.




